## 2019 New Balance Falmouth Road Race Sunday, August 18, 2019

The Cape Cod Commercial Fishermen's Alliance ("Fishermen's Alliance") is an official charity partner of the 2019 New Balance Falmouth Road Race. We are seeking applicants who have a passion for running and a commitment to supporting the Fishermen's Alliance mission of working together with fishermen, community members, public officials and scientists to build creative strategies, advocate for improved marine policies, protect the ocean ecosystem, and ensure the viability and future of Cape Cod's fisheries.

Team Manager Caroline Lane and/or Staff Member Christa Danilowicz will contact vou directly to schedule an interview. Fundraising Commitment: A minimum fundraising requirement of \$1,500 is required to join the Fishermen's Alliance Race Team. If your application is accepted, you will be required to provide your credit card information that will be used for billing in the event you do not meet the required fundraising minimum. Cancellation Policy: You may decline your participation within 48 hours of being offered a spot on the team. To decline or cancel, you must contact Christa Danilowicz at christa@capecodfishermen.org\_within the required time period. Matching Gift Policy: Many companies match employee charitable contributions. You can check with your employer to see if your company has this program and ask donors if their employers match gifts.
